# **Subcommittee Reports**

### **Hotline (Geier):**

- The group next meets April 1 at 910 Dublin Road; focus will be on incorporation of city utilities' call center into system and hotline capabilities of the region.

#### JIC Logistics (Kochensparger):

- Planning continues for the first meeting of this revived group
- Dan and the board discussed the need to exercise in the JIC and to test JIC operations, especially since public information is reportedly not being tested during the April 29 exercise between Delaware and Franklin counties. It was agreed additional discussion needs to occur before a decision is made on how best to proceed and to work with all of the parties involved, including the Franklin County Emergency Management & Homeland Security.

#### **Membership** (Speight):

- Subcommittee member Elizabeth Kress will manage the membership database; the group will also consider what will be public on the COPIN Web site and what will remain private as some contact information may not be public.
- The membership roster from November 2008 will be kept as the subcommittee works to follow up with the people on that list and develop new roster
- Speight wants to add a couple more members on the subcommittee and then work on developing recruitment tools (PowerPoint presentation and speaker notes)
- Kline will speak at an upcoming Citizen Corps Council meeting but in the future speaker requests should be handled through the membership subcommittee
- Speight met with the suburban PIO group and eight membership applications were given out; she will do an active follow-up with them
- Speight said she will look into bring a regional meeting of the City/County Management Association to Columbus this summer and involve COPIN members
